**JEFFERSON COUNTY, MISSOURI**

WHEREAS, the State of Emergency in Jefferson County, Missouri, remains in effect until modified or rescinded by further Order of the County Executive; and,

WHEREAS, a State of Emergency still exists by virtue of the President of the United States and the Governor of the State of Missouri; and,

WHEREAS, the Missouri Director of the Department of Health and Senior Services (“DHSS”) issued an Order dated April 27, 2020 and the Governor of the State of Missouri issued his guidelines regarding the DHSS order under the Show-Me-Strong Recovery Plan; Phase I Guidelines; and,

WHEREAS, a joint order was issued by the County Executive (20-030.7) and Health Director (20-04-28-01) on April 28, 2020 which fully adopted the Missouri Director of the Department of Health and Senior Services Order dated April 27, 2020 and the Show Me Strong Recovery Plan: Phase I Guidelines of the Governor of the State of the Missouri; and,

WHEREAS, this Order which becomes effective at 12:01 a.m. CDT on August 31, 2020, and shall supersede the previous Stay-at Home orders, Restaurant Orders and Reopening Guidelines, their extensions, and amendments issued by the Board of Trustees of Jefferson County Health Center and not otherwise inconsistent with this new Order; and,

WHEREAS, the COVID 19 positivity rate of Jefferson County residents increased from 3.5% when the Stay at Home Order was lifted on May 4th, to 11.6% during the most recent week ending August 22, 2020; and

WHEREAS, it took 95 days from the first identified case of COVID-19 in Jefferson County for the total number of cases to get to 500, another 28 days to go from 500 to 1000 cases but only 25 days to go from 1000 to 2000 cases; and

WHEREAS, within the past 30 days (7/26/20-8/25/20) there have been 1,287 new identified active Jefferson County COVID-19 cases, which is a 100% increase over the course of the last month.

WHEREAS, Jefferson County new positive COVID-19 cases reported per month have increased from 228 cases in April, 84 cases in May, 181 cases in June, 886 cases in July and 1,144 cases in the first 26 days of August; and,

WHEREAS, the current conversion rate for week ending August 22, 2020, for contacts to a positive case that convert to a positive case is 12.05%; and

WHEREAS, the above information indicates that since the expiration of the April 28,2020 order COVID-19 cases have increased substantially; and

WHEREAS, the spread of COVID-19 is expected to continue to grow at a substantial rate; and

WHEREAS, the current level of spread of the disease adversely affects the ability of the Jefferson County Health Center to provide contact tracing to further control community spread and has the potential to overwhelm the community's medical resources; and

WHEREAS, in addition to overwhelming the medical system and threatening the health and lives of residents, the spread of the disease will cause economic damage, disruption and hardship in the event the County finds it necessary to return to the former stay at home orders in order to reduce the spread of the disease; and

WHEREAS, due to the escalating spread of the COVID-19 pandemic it is necessary for the immediate preservation of public health, safety and welfare of the residents of Jefferson County to take steps to mitigate the spread of the disease; and to continue to prevent the entrance of infectious contagious, communicable, or dangerous diseases into the county; and

WHEREAS, the key transmission method for the COVID-19 virus is through respiratory droplets that people expel when they breathe, speak, cough, or sneeze; and

WHEREAS, people can be infected with the COVID-19 virus and be asymptomatic or pre-symptomatic but still be contagious to others; and

WHEREAS, published studies have found that widespread use of a face mask is necessary to prevent the more rapid spread of the COVID-19 virus, and thereby necessary for the safety and health of Jefferson County residents and visitors; and

WHEREAS, the United States Centers for Disease Control and Prevention has recommended that members of the public, when they need to interact with others outside the home, and especially in indoor settings should cover the mouth and nose to prevent inadvertently spreading COVID-19; and

WHEREAS, the wearing of a mask by patrons and employees to the greatest extent possible may enable businesses to remain open while protecting the health and safety of the public and employees and keeping the local economy strong during the period in which the disease is being brought under control in the community; and

WHEREAS, by the passage of this ordinance, the Jefferson County Health Center Board of Trustees finds that wearing a face mask is an appropriate and necessary method of reducing the spread of COVID-19 and will be the least restrictive means imposed with the greatest benefit to reduce community spread; and

WHEREAS, strict use of face masks or coverings may limit the spread of COVID-19 to such an extent that further Stay at Home Orders may not be needed; and

WHEREAS, the Board of Trustees of the Jefferson County Health Center have the authority to promulgate orders, ordinances, rules or regulations respectfully, as will tend to enhance the public health and prevent the entrance of infectious, contagious, communicable or dangerous diseases into such county pursuant to Section 192.300 RSMO to protect the health and safety of the Citizens of Jefferson County, Missouri, by implementing these limited and temporary rules, regulations and restrictions; and,

WHEREAS, Community mitigation activities are actions that people and communities can take to slow the spread of a new virus with pandemic potential. COVID-19 is an infectious disease caused by a new coronavirus. Community mitigation actions are especially important before a vaccine or therapeutic drugs becomes widely available; and,

WHEREAS, the goals for using mitigation strategies in communities with local COVID-19 transmission are to slow the transmission of disease and in particular to protect people at increased risk for severe illness and the healthcare and critical infrastructure workforces; and

WHEREAS, this Order is not intended to supersede the Federal, State and/or Local public health officials Orders, but shall be read in conjunction with the same.

NOW THEREFORE, the Jefferson County Health Center Board of Trustees Order:

Section 1: By virtue of the authority vested in Board of Trustees of the Jefferson County Health Center by the Missouri Constitution, the Laws of the State of Missouri, Chapter 192 RSMO, the following order shall go into effect at 12:01 a.m. on August 31, 2020 after its passage by three-fifths of the members of the Board of Trustees and shall remain in effect until September 25, 2020 or until it is extended, rescinded, superseded or amended in writing by later adopted order.

Section 2. All places of public accommodation shall institute as outlined herein appropriate health and safety protections including physical distancing techniques (e.g. requiring people to be at least six feet apart; reducing the number of employees or customers, or other people present; reducing face-to-face contact and keeping the same to a minimum; using phone calls, virtual meetings and drop-offs/curbside pickups rather than in-person contact.)

For purposes of this Ordinance, “place of public accommodations:” means a business or an education, refreshment, entertainment or recreation facility or an institution of any kind, whether licensed or not, whose goods, services, facilities, privileges, advantages or accommodations are extended, offered, sold or otherwise made available to the public. Place of public accommodation includes facilities of private clubs, including country clubs, golf clubs, sports clubs, athletic clubs and dining facilities and places of worship.

Section 3: Citizens should limit unnecessary travel as much as is practical; ensure proper hygiene to the greatest extent possible; continue to utilize electronic financial and other transactions; and restaurants are urged to promote and continue, even while allowed to fully open, a full take out service as much as possible.

**Section 4:** Gatherings and places of public accommodation shall be limited in any one place and any one time under this ordinance to ensure individuals maintain 6 foot physical distance and required face mask can be ensured.

**Section 5:** Wearing of Face Masks Required. Except as otherwise provided in this ordinance all persons age five years old and above who are present within Jefferson County are required to wear a clean Face Mask any time they are, or will be, in contact with other people who are not household members. CDC recommends all people 2 years of age and older wear a mask in public settings and when around people who don't live in your household, especially when other social distancing measures are difficult to maintain.

Definition. As used in this ordinance, a "Face Mask" means a covering made of cloth, fabric, or other soft or permeable material, without holes, that covers only the nose and mouth and surrounding areas of the lower face. A covering that hides or obscures the wearer's eyes or forehead is not a Face Mask. A Face Mask may be factory-made, or may be handmade and improvised from ordinary household materials.

Any mask that incorporates a one-way valve (typically a raised plastic cylinder about the size of a quarter on the front or side of the mask) that is designed to facilitate easy exhaling allows droplets to be released from the mask, putting others nearby at risk. As a result, these masks are not a Face Mask under this Ordinance and must not be used to comply with this Ordinance's requirements.

**Section 6:** Employers to Provide Face Masks to Employees. Any time an employee or staff person is required to wear a Face Mask pursuant to this ordinance, the employer shall make face masks available in sufficient quantity to assure each employee can wear a clean Face Mask at all times.

**Section 7:** Exempted Activities. A person may remove their Face Mask where otherwise required under the following circumstances:

- a. While outdoors when able to maintain a distance of at least six feet from others;
- b. While exercising outdoors or while exercising indoors when able to maintain a distance of at least six feet from others;
- c. When engaged in a sporting activity;
- d. While at home and exclusively in the presence of members of their own household;
- e. When in your or your family's personal vehicle;
- f. While eating or drinking only when inside or in the outside dining area of a restaurant or other establishment that offers food or beverage service, provided that person is able to maintain a distance of at least six feet from persons seated at other tables, and provided this distance restriction is enforced by the restaurant or other establishment;
- g. When an individual has a medical condition, mental health condition or disability that prevents wearing a Face Mask;
- h. When any party to a communication is deaf or hard of hearing and not wearing a Face Mask is essential to communication;
- i. While obtaining a service that requires temporary removal of the Face Mask, such as dental examinations;
- j. When necessary to confirm the individual's identity;



- k. When federal or state law prohibits wearing a Face Mask or requires the removal of a Face Mask;
- l. When requested by a law enforcement officer;
- m. When requested by a medical provider, including emergency response personnel;
- n. When in a business/commercial/office setting and not within six feet of any other person; provided however, when moving from place to place in a business location where the person cannot maintain at all times a distance of six feet from all other persons a Face Mask shall be worn;

Section 8: If any part of this Order is invalid for any reason, such invalidity shall not affect the remainder of this Order.

**Jefferson County Health Center Board of Trustees Revokes Ordinance 20-08-27-01**

The Jefferson County Health Center Board of Trustees met in an emergency meeting on Friday, August 28<sup>th</sup>, to revoke Ordinance Number 20-08-27-01. The vote was 5 in favor and 0 against. The decision was made to hold the emergency meeting after concerns were raised regarding whether or not the Board had followed proper procedures for notification of the public prior to the meeting.

It is extremely important to the Board and Director of the Health Center that residents feel confident in the process that is used when preparing public orders. The full document of the proposed ordinance has been posted online and distributed to the community for further review through elected officials, schools and will be posted on the Health Center's webpage. The Board has not determined a date for a future meeting to discuss the proposed order.
